I PURPOSE

This work instruction is to provide quality assurance requirements information to be part of all Purchase orders generated by QED personnel. A copy of this WI shall be posted on the QED, Inc. website. QED purchase orders will reference appropriate QAP's for all goods and services that are to be used in QED manufactured products. It will be the suppliers responsibility to access the applicable referenced QAPs.

II SCOPE

This work instruction establishes definitions for each code printed or recorded on QED purchase order form.

III Product category

Α

Products or services that conform to purchasing documents that are verified at QED by reviewing the certification supplied by the supplier (i.e. Calibration, Plating, Heat-treat, Nondestructive testing, Military or other non-QED/inc. specifications, etc.)

В

Product or services that conform to purchasing documents requiring verification upon receipt at QED (i.e. Sub assemblies, parts made for QED based on QED/inc. Drawings and/or QED/inc. specifications, etc.)

C

Products or services that are not subject to quality review. Items in this category should never be used in a shippable product.

D

Customer supplied raw material or components.

QAP7	machined surfaces, sealing surfaces and other critical attributes during
	manufacture, processing and shipment of QED products.
QAP8	The supplier shall inspect and verify key characteristics. (These features
	shall be identified on the purchase order and designated with "KEY" symbol).

QAP9	The supplier shall maintain a Software control Plan in accordance with or

QAP11	Stripping and re-plating are not permitted without prior approval of QED.

QAP 17	The supplier shall maintain a documented FOD prevention program. The program shall be compliant with National Aerospace Standard NAS-412:

QAP 18	Persons carrying out purchased services or providing purchased materials shall be competent on the basis of skills, experience, and/or training and shall be aware of their contribution to product and service conformity and product safety. They shall also be aware of the importance of ethical behavior.
QAP 19	Supplier shall notify QED of nonconforming processes, products or services and obtain approval for their disposition.
QAP 20	Supplier shall use the customer-designated or approved sub-tier supplier provided in the Purchase Order instructions. Deviations are not permitted.
QAP 21	Supplier shall flow down application requirements to sub-tier suppliers
QAP 22	Supplier is required to provide test specimens. Refer to the Purchase Order for required quantity, dimensions, material, condition, etc. as applicable.
